When services are paid in full as set out in the <u>pre-need</u> contract, the contract is guaranteed and the total payment will be applied to the future price of services and supplies. Any changes to the pre-paid contract may result in the pre-paid contract being null and void and a new contract being executed with current pricing at the time changes are made.
